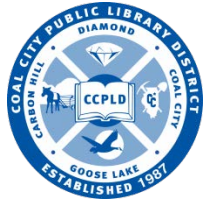

must be signed.

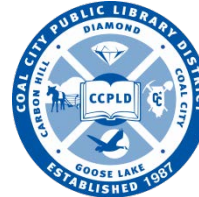
-A limit of 5 pieces per person can be displayed.

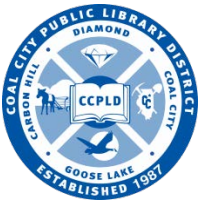

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

In consideration for receiving permission to participate in the 7th Annual Photography Exhibit, (“the program”) from April 15, 2019 through May 15, 2019, I hereby release, waive, discharge and covenant not to sue the Coal City Public Library District, its officers, servant, agents and employees (hereinafter referred to as “releases”) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss or damage that may be sustained to any property belonging to me, whether caused by negligence of the releases, or otherwise, while participating in the program, or while on or upon the premises where the program is being conducted, while in transit to or from the premises, or in any place or places connected with the program.

I am fully aware of risks and hazards connected with being on the premises and participating in the program, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the program, and I hereby elect to voluntarily participate in the program, to enter upon the above named premises property. I voluntarily assume full responsibility for any risks or any loss or damage to property owned by me, as a result of my being a participant in the program, whether caused by the negligence of the releases or otherwise.

I further hereby agree to indemnify and save and hold harmless the releases and each of them, from any loss, liability, damage or costs they may incur due to my participation in the Program, whether caused by negligence or any or all of the releases, or otherwise.

It is my express intent that this Release shall bind the members of my family and spouse, if I am alive and my heirs, assigns and personal representative if I am deceased, and shall be deemed as a Release, Waiver, Discharge, Covenant Not to Sue the above named releases.

In signing this release, I acknowledge and represent that:

- A. I have read the forgoing release, understand it and sign it voluntarily as my own free act and deed;
- B. No oral representation, statements or inducements, apart from the forgoing written agreement, have been made;
- C. I am at least 18 years of age and full competent; and
- D. I execute this Release for full, adequate and complete consideration fully intending to be bound by the same.
