WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

In consideration for receiving permission to participate in the 27th Annual Quilt Display, (“the event”) from October 14, 2019 through November 14, 2019, I hereby release, waive, discharge and covenant not to sue the Coal City Public Library District, its officers, servant, agents and employees (hereinafter referred to as “CCPLD”) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss or damage that may be sustained to any property belonging to me, whether caused by negligence of CCPLD, or otherwise, while participating in the event, or while on or upon the premises where the event is being conducted, while in transit to or from the premises, or in any place or places connected with the event.

I am fully aware of risks and hazards connected with being on the premises and participating in the event, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the event, and I hereby elect to voluntarily participate in the event, to enter upon the above named premises. I voluntarily assume full responsibility for any risks or any loss or damage to property owned by me, as a result of my being a participant in the event, whether caused by the negligence of CCPLD or otherwise.

I further hereby agree to indemnify and save and hold harmless CCPLD and each of them, from any loss, liability, damage or costs they may incur due to my participation in the event, whether caused by negligence or by any or all of CCPLD, or otherwise.

It is my express intent that this Release shall bind the members of my family and spouse, if I am alive and my heirs, assigns and personal representative if I am deceased, and shall be deemed as a Release, Waiver, Discharge, Covenant Not to Sue the above named CCPLD.

In signing this release, I acknowledge and represent that:

- A. I have read the forgoing release, understand it and sign it voluntarily as my own free act and deed;
- B. No oral representation, statements or inducements, apart from the forgoing written agreement, have been made;
- C. I am at least 18 years of age and fully competent; and
- D. I execute this Release for full, adequate and complete consideration fully intending to be bound by the same.
